FIRE BANS

RURAL MUNICIPALITY OF EYEBROW NO. 193 BYLAW NO 1-2020 A BYLAW FOR ENACTING A FIRE RESTRICTION OR FIRE BAN

The Council of the Rural Municipality of Eyebrow No. 193 in the Province of Saskatchewan may enact a Fire Ban or Fire Advisory in consultation with the Eyebrow & District Fire Protection Society Inc.; as indicated below:

1. FIRE ADVISORY

Open burning in the municipality is not recommended due to dry conditions. It is recommended agriculture and industrial operations have filled water tanks at their disposal and assessable at all times.

2. FIRE BANS

Open burning in the municipality is banned due to dry and high-risk fire spread conditions. It is recommended agriculture and industrial operations have filled water tanks at their disposal and assessable at all times.

> LEVEL 1 Fire Ban

Open burning in the Rural Municipality of Eyebrow is banned.

A level 1 fire ban includes unsupervised burning barrels.

Exemptions to a Level 1 Fire Ban, (with a plan to extinguish a fire) are:

- a) Supervised incinerators (for farm, acreage, and hamlet use)
- b) Burning barrels with screens under constant supervision
- c) Solid fuel barbecues/recreational camp fires (as per schedule A)
- d) Liquid fuel barbecues (propane or natural gas)
- e) Camp stoves
- f) Fireworks

LEVEL 2 Fire Ban

Open burning in the Rural Municipality of Eyebrow is banned.

A Level 2 Fire Ban includes:

- a) Incinerators (for farm or acreage use)
- b) All burning barrels
- c) Fireworks

Exemptions to a Level 2 Fire Ban, (with a plan to extinguish a fire) are:

- a) Camp stoves
- b) Solid fuel barbecues/recreational Camp Fires (as per schedule A)
- c) Liquid Fuel Barbecues (propane or natural gas)

LEVEL 3 Fire Ban

Open burning in the Rural Municipality of Eyebrow is banned.

A Level 3 Fire Ban includes:

- a) Incinerators
- b) All Burning barrels
- c) Solid Fuel Barbecues/Recreational Camp Fires (as per schedule A)
- d) Camp stoves
- e) Fireworks

Exemptions to a Level 3 fire ban are:

a) Liquid Fuel Barbecues (propane or natural gas)

3. OFFENCES AND PENALTIES

Every person who contravenes this Bylaw is guilty of an offence and liable on summary conviction of up to toward \$1,500 in additions to fire fighting fees if required.

SCHEDULE "A"

To Bylaw 1-2020

A Bylaw for Enacting A Fire Restriction or Fire Ban

Solid Fuel Barbeques and Recreational Campfires are permitted under certain provisions of the Fire Ban Bylaw, providing:

- 1. Fire must be under constant supervision by and adult.
- 2. Enclosed fire pits or barbeques must be covered with a metal screen having openings no greater than 1/2 inch and must cover the entire opening. Logs or other fuel source must be fully contained within the enclosure. Embers and ash must be prevented from escaping the enclosure.
- 3. The fire pit/barbeque must be a distance of at least 2 feet from any grass and 10 feet from any combustible structure or item.
- 4. Be prepared, and have a plan to extinguish a fire should it escape from the fire pit/barbeque.
- 5. Fire and embers must be extinguished completely when not under constant supervision.
- 6. Fires are only permitted during the following hours:

Sunday-Thursday Prior to 11:00 p.m.

Friday-Saturday Prior to 1:00 a.m.

7. Absolutely no burning in wind speeds above 15 km/hour.
