The Rural Municipality of Rudy No. 284 invites tenders to load, haul and spread gravel on RM of Rudy roads in 2025.

- 1. <u>Specifications:</u>
 - a) Gravel to be loaded, hauled and placed: approximately 11,600 cubic yards
 - b) Pit location: SE 30-27-7-W3rd
 - c) Roadways: within the RM of Rudy No. 284 (max speed 60 km/hr)
 - d) Time: spring/summer 2025
- 2. <u>Contractor:</u>
 - a) The contractor will provide all equipment, labor, supervision and other things necessary to complete the work described in the specifications.
 - b) The contractor will take direction from the RM of Rudy Foreman as to which gravel to load and haul, and which roadways to place gravel at.
 - c) The contractor will adequately insure the vehicles and equipment used to perform the work, and provide evidence of coverage to the RM of Rudy before commencing work.
 - d) The contractor will have Comprehensive General Public Liability coverage in the amount of \$2 million (or greater) per occurrence or incident.
 - e) All equipment used by the contractor must be up-to-date on Safety Inspections.
 - f) The contractor will provide a letter of good standing with the Saskatchewan Workers Compensation Board, and will be responsible for WCB premiums.
- 3. <u>Tender Package should include:</u>
 - a) A listing of the equipment to be used for loading, hauling and placing the gravel.
 - b) Evidence of Comprehensive General Public Liability Insurance.
 - c) A letter of good standing with the Saskatchewan Workers Compensation Board.
 - d) An indication of whether the contractor is interested in or available for spot gravelling
 - e) Proposed unit price stated per cubic yard per mile loaded. The unit price proposed shall include the supply of all equipment, labour, supervision and all other things required to complete the work.
