
BYLAW NO. 02/25

**A BYLAW TO AUTHORIZE FEES AND CHARGES FOR MUNICIPAL SERVICES
AND PRODUCTS**

The Council of the Rural Municipality of Rudy No. 284 ("The Municipality") in the Province of Saskatchewan pursuant to Section 8 and 12 of *The Municipalities Act* enacts as follows;

1. This Bylaw may be referred to as the *Fees and Charges Bylaw*.
2. In this Bylaw:
 - a) "Municipality" shall mean the Rural Municipality of Rudy No. 284
 - b) "Council" shall mean the duly elected council for the Rural Municipality of Rudy No. 284
 - c) "Customer" shall mean any natural person or persons who received the service or product, including: an individual, sole proprietorship, partnership, corporation, trust, joint venture, or any incorporated or unincorporated entity or association of any nature.
3. This Bylaw shall apply to any customer who required goods or services supplied by the Municipality.
4. The fees and charges set out in the following Schedules attached to and forming part of this Bylaw are set fees and charges for:
 - a) Schedule A – Administration
 - b) Schedule B – Building and Development
 - c) Schedule C – Custom Work
 - d) Schedule D – Pest Control
5. Bylaws 01-2006 and 01-2022 are hereby repealed.
6. This Bylaw shall come into effect upon passing, on April 9, 2025.

Sale of products that are approved by the Pest Control Officer will only be offered to RM of Rudy ratepayers and will be priced at cost.
