Road Construction

- Road construction has begun to lay cap two miles on Range Road 3110, W 7 & 18-35-10-W3 (Kinley Grid South). Please follow all road detours and closures during construction.
- The bridge repair on NW 32-34-10-W3, which had a girder fail on the south side, is now complete.

PCO & Weed Control

- We would like to welcome Owen Zoerb as the Pest Control Officer, and Nicole Couture as our Weed Inspector for the R.M. of Perdue.
- The R.M. office will no longer be distributing poison or bait boxes. For pest control products, please contact Owen Zoerb, 306-381-3377.
- Rozol bags are available for gopher control. Each 22.7 KG bag costs \$236.50. SARM offers a 50% rebate for ratepayers who complete the rebate form and return it to the R.M. office by July 31st.

NEW* Dust Control

- The R.M. of Perdue has implemented a dust control program to allow a 50% rebate for dust control applications. All rebates are to be pre-approved by Council prior to payment, under the following conditions:

- Maximum 200 yards per application
- Maximum 2 applications per year, per property

Payments are retroactive for the year 2025. Application forms are available at the R.M. office or on the municipal website. Please contact your Councilor for more information.

NEW* Snow Removal

- Optional residential snow removal on private lanes is now available for ratepayers of the R.M. of Perdue. The minimum cost is \$100.00 for the first hour, and \$100.00 for each additional hour. Private lane snow removal will commence only after all municipal roads are completed.

- Owners are required to sign the custom work order form, with a general release of liability, prior to any custom work. Please contact the RM office to schedule any custom work.

- A reminder that ratepayers who are interested in a GFL waste bin must contact the R.M. office to order a bin. The R.M. of Perdue will subsidize 30% of the cost for one four-yard or six-yard waste bin.

- The R.M. is not responsible for the collection schedule or pickup delays. For questions regarding pickup delays, please contact GFL at 306-244-9500.

Planning and Development

- A reminder that any new building construction, addition, renovation, structural change, or relocation to a new site, will require a building permit and will be subject to a building inspection.

- Fees for building permits are invoiced from the R.M. to the ratepayer. The building permit invoice must be paid by the ratepayer before the permit is released, and work can commence.

- Building permits and development permits are available at the R.M. office.

- Farm buildings without sleeping quarters, and for agricultural purposes only, are exempt from construction standards and do not require a building permit. Ratepayers **must** complete the farm exemption form to self-declare that they are exempt.

- If you are unsure if your renovation or new build requires a building permit, please contact Construction Code Authority at 306-386-7777, or visit their website at <https://ccask.ca>

R.M. Well

- The R.M. has installed a timer at the R.M. shop well, to eliminate water waste and spillovers. Both R.M. wells are for ratepayer use and agricultural purposes only.

Grain Bag Roller

- The R.M. of Perdue has a grain bag roller for **ratepayer use only**. Please contact the R.M. office to schedule use of the grain bag roller.

Discing and Spraying

- Please **do not** disc or spray the municipal road allowances. It is eroding the roadbeds, and we are losing the sides of the road. Any fieldwork being done should only be to the toe of the slope.

Control Burn

- Controlled burns must be reported to the Provincial control burn line at 1(866) 404-4911. Callers are required to call back once the burn is complete. Call-out fees will apply if the fire department is dispatched for a false alarm.

- In case of a fire on your property, please ensure to have adequate fire insurance coverage.
