
RURAL MUNICIPALITY OF PONASS LAKE NO. 367

BYLAW NO. 1/21

A BYLAW TO PROVIDE FOR THE CONTROL OF APPLICATION OF ANY SUBSTANCE TO A PUBLIC ROADWAY

The Council of the Rural Municipality of Ponass Lake No. 367, in the Province of Saskatchewan, enacts as follows:

- 1. No person shall apply any substance to a public roadway without the prior written authorization of council for the Rural Municipality of Ponass Lake No. 367 as outlined in the dust control agreement, marked as Exhibit "A" which is attached to and forms part of this bylaw.
- 2. Any person who violates this bylaw is guilty of an offence and shall be liable on summary conviction to the penalties as provided in the general penalty bylaw of this municipality.
- 3. This Bylaw shall come into force on the day of its final passing.


