**RURAL MUNICIPALITY OF PONASS LAKE NO. 367**

**BYLAW NO 4/16**

**A BYLAW TO PROVIDE FOR THE MUNICIPALITY TO ENTER INTO AN AGREEMENT RESPECTING THE PROVISION OF FIRE PROTECTION SERVICES/BILLINGS WITH THE MUNICIPALITIES AND FIRE DEPARTMENTS OF THE WADENA AND DISTRICT FIRE ASSOCIATION**

The Council of the Rural Municipality of Ponass Lake No. 367 in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be referred to as the Wadena and District Fire Protection Agreement Bylaw.
2. In this bylaw:
  - a. "Administrator" shall mean the administrator of the municipality;
  - b. "Council" shall mean the council of the municipality;
  - c. "Head of council" shall mean the mayor or reeve of the municipality, as the case may be;
  - d. "Municipality" shall mean the Rural Municipality of Ponass Lake No. 367;
3. The Rural Municipality of Ponass Lake No. 367 is hereby authorized to enter into an agreement with the Municipalities and Fire Departments of the Wadena and District Fire Association.
4. The agreement is attached hereto and forms a part of this bylaw, and is identified as "Exhibit A".
5. The head of council and the administrator are hereby authorized to sign and execute the agreement described as Exhibit A.
6. Bylaw No. 4/15 is hereby repealed.

WHEREAS the parties named above desire to continue to associate with each other for the purpose of furthering their learning education from each other and maintaining their friendly working conditions.

NOW, THEREFORE, this agreement witnesseth that in consideration of these presents and covenants, promises and agreements hereinafter contained, the parties jointly and severally agree as follows:

For a request of assistance from a neighboring Fire Department the following rates will be used:

Pumper truck	\$700.00 for 1 <sup>st</sup> hour
	\$300.00 for the 2 <sup>nd</sup> and each additional hour thereafter
2 <sup>nd</sup> pumper truck	\$300.00 per hour
Tanker	\$250.00 per hour
Rescue Van	\$250.00 per hour
Man hours	\$20.00 per hour, no minimum charge
Foam	\$275.00 per pail



## DISTRICT FIRE FIGHTING AGREEMENT

When called to fight a fire in another area, the Department will contact the Home Fire Department and the billing will be done at regular mutual aid rates by the Fire Department responding.

It is mutually agreed by all parties concerned that in the event of absence of firefighting equipment in a member town because of assistance being rendered to another Fire Department the closest member Fire Department will be notified of the absence and also of the return of equipment to the absented fire hall. There will not be a monetary charge in this regard for the standby service.

The rates of this agreement may be reviewed at any further date.
