RURAL MUNICIPALITY OF PONASS LAKE NO. 367

BYLAW NO. 5, 1990

A bylaw of the Rural Municipality of Ponass Lake No. 367 to designate the property known as the Babulynci (BBA) Church located on a portion of the NE 9-37-14 W2 in the Province of Saskatchewan as being a site of architectural and historical value.

WHEREAS part 111 of The Heritage Property Act authorizes the council of a municipality to enact bylaws to designate real property, including all buildings and structures thereon, to be of architectural, historical or natural value or interest; and

WHEREAS the Council of the Rural Municipality of Ponass Lake No. 367 has caused to be served on the owners of the lands and premises known as the Babulynci (BBA) Church on a portion of the NE 9-37-14 W2 a Notice of Intention to so designate the aforesaid real property and has caused suchNotice of Intention to be published in at least two issues of a newspaper with general circulation in the municipality with the first publication at least twenty-one (21) days prior to the date of consideration of the bylaw and with the last publication at least seven (7) days prior to the date of that consideration; and

WHEREAS no Notice of Objection to the proposed designation has been served on the administrator of the municipality;

THEREFORE, the Council of the Rural Municipality of Ponass Lake No. 367 enacts as follows:

 There is designated as being of architectural and historical value or interest the real property known as the Babulynci (BBA) Church in the Rural Municipality of Ponass Lake No. 367 and legally described as:

All that portion of the North East Quarter of Section Nine (9) in Township Thirty-seven (37) in Range Fourteen (14), West of the Second Meridian, in the Province of Saskatchewan in the Dominion of Canada, more particularly described as follows:

COMMENCING: At the North East corner of the said Quarter Section thence Westerly along the Northerly limit of the said Quarter Section Four Hundred and Twenty-nine (429) feet to a point, thence Southerly and parallel to the Easterly limit of said Quarter Section Four Hundred and Ninety-five (495) feet to a point thence Easterly and parallel to the the Northerly limit of said Quarter section Four Hundred and Twenty-nine (429) feet to a point in the Easterly limit thereof thence Northerly along the Easterly limit of said Quarter Section Four Hundred and Ninety-five (495) feet, more or less, to the place of beginning, the land containing Four and Eighty Hundred and Seventy-five Thousandths (4.875) acres, more or less,

EXCEPTING: All Mines and Minerals as the said Mines and Minerals were reserved by Transfer registered as No. 0 1206.

The significance of the site is as follows:

- a. Constructed in 1931, the Babulynci Church is one of the earliest Churches built in the Rural Municipality of Ponass Lake No. 367.

- b. The architectural designs of the Church reflect Ukrainian motifs.
- c. The Church is a landmark in the community.
- 2. The rural administrator is hereby authorized to cause a copy of this bylaw to be registered against the property described above in the proper Land Titles Office.
- 3. The rural administrator is hereby authorized to cause a copy of this bylaw to be served on the owner of the aforesaid property and on the Minister and to cause notice of the passing of this bylaw.
- This bylaw shall come into force and take effect on the day of the final passing thereof.
