NEW RESIDENCE ACCESS ROAD DEVELOPMENT POLICY

Purpose of Policy: To assure all new residence access roads are built to RM standards and to allocate some of expected costs to the Ratepayer requesting the new access road.

A New Residence Access Road Application Form (attached to this policy) must be completed and be presented at the next Regular Meeting of Council for approval and proposal of costs to the Ratepayer prior to the access road being built.

Upon completion of road construction, a maximum amount of 400 yards per mile of gravel can be applied to the road at the RM expense. The full 400 yards per mile of gravel can be taken over time as needed.

If the road is developed to RM standards the RM will maintain the access road in accordance with RM policies.

RM of Reno Road Definitions Policy

Resolution No. 2025-070 Moved By: HEGLUND

That the RM of Reno Road Definitions Policy be accepted as presented. Further, that the policy shall be as follows:

RM of Reno ROAD DEFINITIONS Policy:

Purpose of Policy – To define the RM road system using the Rural Road Classification Criteria and priority of road maintenance. Colors coincide to road legend on RM of Reno map.

Primary Grid (Green) Class 4 – Clearing the Path Corridors – Primary Weight - Maintained year-round with priority grading and plowing.

Grid Road - Gravel (Red) Class 5 – Main Roads – Secondary Weight – Maintained year-round. Grid Road Definition: 7.6 meters wide – ditch bottom is 15 - 20ft wide – backslope of 5:1. Priority grading and plowing.

Municipal Roads - Graveled (Brown) Class 6 – Secondary Weight - Maintained year round

Farm Access Roads - Graveled (Blue) Class 6 - Maintained year-round. Graded twice per year. Snowplowed as needed and as request by councillor for that division.

Municipal Roads Seasonal (Grey) Class 7 – Maintained and gravelled at council discretion through summer months, not year-round roads, least priority. Only snow plowed if time allows upon councillor of that division's discretion.

Bladed Trails (Purple) Class 7 – Graded (bladed) at least once per year as per condition. No snowplowing unless requested by council for a ratepayer. Custom rates will apply.

Undeveloped Road Allowance (White) – No roads, no maintenance.

The RM of Reno No. 51 is now accepting tenders for gravel hauling and spreading from stockpiles located in three locations throughout the municipality.

Tenders shall include prices for loading, hauling, and spreading approximately 11,000 yards of gravel over approximately 110 miles, plus approximately 38 farm access roads. Quantities and miles subject to change.

Tenders shall include price per cubic yard for loading, price per cubic yard per mile of haul (noting minimum haul charge if applicable), plus any additional surcharges or mobilization charges.

Tenders must include a list of equipment/machinery to be used for the completion of the gravel loading and hauling. Tenders must include documentation for provincial requirements (i.e.: WCB, Vehicle registrations and insurance etc.)

The contractor selected shall be required to sign a contract with the RM outlining the timing, location, and a system to verify quantities. Hauling and spreading of gravel quantities must be completed by **July 30, 2025**; barring weather conditions.
